be at my side.**

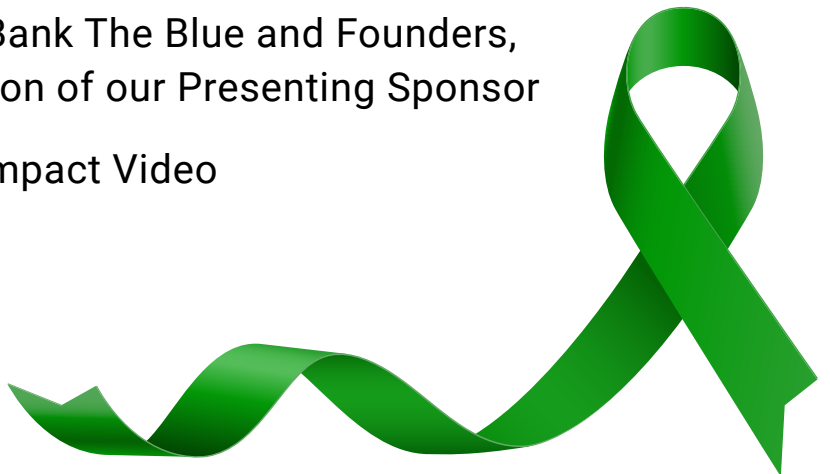

BANK THE BLUE is a 501(c)3 non-profit organization that was launched in March 2020.

OUR MISSION is to provide funding and access for mental health services to Illinois law enforcement officers dealing with multiple psychosocial stressors both on and off the job. Our fundraising efforts are implemented in partnership with police officer training programs and certified, culturally competent clinicians who specialize in treatments oriented for the unique needs of Law Enforcement Officers.

Now, more than ever, many police officers struggle with mental health issues due to their constant exposure to violent and traumatic situations; local departments alone cannot meet their dire needs. Bank the Blue is determined to fill this gap. According to mental health experts, the rate for post-traumatic stress disorder and depression among police officers is five times higher than that of the civilian population and often goes untreated.

According to the U.S. Department of Justice's 2017 report, Chicago's police suicide rate is 60 percent higher than the national law enforcement average. We need healthy and engaged law enforcement officers working in partnership with the communities they serve.

Recognizing that seeking outside mental health treatment can be daunting, Bank the Blue streamlined the process and made access to respected providers simple. Bank the Blue partnered with field experts to provide extensive, certified training programs. They provide officers with a variety of ways to approach difficult and/or stressful situations.

On behalf of the Bank the Blue Founders & Board of Directors, we would like to thank everyone in attendance tonight at our Third Annual Gala and for supporting Bank the Blue's mission.

This evening is meant to show our Illinois law enforcement officers that the community overwhelmingly supports them and recognizes the unique trauma law enforcement is exposed to daily. By gathering here this evening, we are collectively showing Illinois officers that their mental health matters.

It's been a busy year for Bank the Blue! Since our Second Fundraising Gala last October, we began to really see our vision in motion. We have ten, fully vetted, culturally competent clinicians participating in our confidential referral program. Bank the Blue is currently fully funding treatment for 39 Illinois law enforcement officers through our program and over 350 therapy sessions are currently scheduled.

Bank the Blue fully funded Dr. Olivia Johnson's presentment of the Fatal 10 of Law Enforcement Suicide for over 1,000 Illinois law enforcement officers from over 47 different agencies at the local, county, state, and federal levels. The feedback received from this program was nothing short of spectacular.

In 2023, Bank the Blue's Ambassador Program trained over 25 retired Illinois Officers to attend roll call visits to spread awareness of Bank the Blue's resources and programs.

Bank The Blue attended multiple police outings and conferences. All of these events provided us an opportunity to network with law enforcement agencies and nonprofits from across the state but also to connect with officers directly.

As an assistant state's attorney, he began by prosecuting DUIs, and his continuous hard work and success saw him promoted to the Felony Narcotics Unit, where he handled street level and long-term conspiracy cases. He spent his final year in the FeloXny Trial Division prosecuting violent crimes, including armed robberies, criminal sexual assaults and murders, serving as lead attorney in over 100 trials and further developing his expertise as a litigator and an aggressive advocate.

Given the opportunity to serve as in-house counsel for the Fraternal Order of Police, Dan left the state's attorney office and presided over Chicago Lodge #7 for the ensuing five years. FOX 32 Good Day Chicago Anchor

Anita Padilla is an American award-winning television journalist best known as an anchor and reporter working on stories that impact the lives of Chicagoans. She currently works at Fox 32 News in Chicago and anchors Good Day Chicago from Monday to Friday. Prior to joining Fox 32 News in Chicago, Anita worked as a news reporter at WMAQ-TV, an NBC-owned and operated television station in Chicago.

A native Chicagoan, Anita earned a B.A. in Broadcast Journalism from Columbia College Chicago. Her first reporting work was as an intern for Bill Kurtis at WBBM-TV, later working in radio as an anchor and at Shadow traffic as a traffic editor. She also worked at WFTV in Orlando, Florida, where she helped to run a news bureau.

In 1995, Anita earned her first of two career Emmy Awards for breaking news coverage of an armed robbery and carjacking by a murderer in Orlando. In 2000, she earned a second Emmy for her role in a New

Year's Eve Millennium celebration piece while at WMAQ Channel 5 in Chicago. Anita continues to report on many high-profile stories across Chicago. She hosted exclusive interviews with Betty Loren-Maltese on the day of her racketeering conviction and again when she was sentenced to eight years in federal prison. She also reported on former Illinois Attorney General Jim Ryan's battle with cancer, the unexpected loss of his young daughter and his wife's heart attack.

In 2013 she was the Northwestern College commencement speaker. "Anita Padilla will bring a flair of excitement as our 2013 commencement speaker," commented President Schumacher. "She's a local success story having grown up in the Chicago suburbs, and we have no doubt that she will inspire our graduates as they celebrate their own personal accomplishments."



Lou Canellis

FOX 32 Sports Anchor

Lou Canellis shares his enthusiasm about sports with Chicagoans every night on FOX 32 News at 5pm and 9pm. Lou also is the main anchor of Fox's thirty minute sports show, The Sports Zone, every Sunday night. He has followed local teams his entire life and has an extensive sports background.

During the Chicago Bears season, Lou is seen all day Sundays on Fox 32 Chicago. He hosts Fox Kickoff Sunday with former Chicago Bears quarterback, Jim Miller, at 10 am followed by Bears GameDay Live with former Chicago Bear Tom Thayer and the voice of the Bears, Jeff Joniak at 10:30 am. Lou also hosts Bears Postgame Live following every game on Fox 32 Chicago and Channel 50 plus the Sports Zone & Bears Game Night Live on Fox 32 Chicago.

Canellis has been going to Bears games since he was four years old, and has been a season ticket holder since he was six years old. Sweet Lou's expertise on the Bears can also be heard on various radio stations such

as WGN, The Score, ESPN Radio and WLS Radio throughout the city on a daily basis.

Canellis first became popular in his hometown as a member of the Chicago Bulls broadcasts on TV and radio. Canellis handled pregame and postgame duties along with being a sideline reporter and was well-known for his post-game chats with Michael Jordan.

Lou also spent 10 years as a reporter/host on the wildly popular Entertainment Lifestyle Show 190 North on ABC 7 in Chicago. In addition, during the course of his career he worked for 17 years for ESPN as a college basketball play-by-play announcer at ESPN Radio and WSCR as a talk show host.

A Loyola University graduate, Canellis considers himself a "South Sider," having been born and raised in Oak Lawn.

Canellis is a six-time Emmy Award winner.

Lou and his wife Monica have a daughter, Gia along with their dog, Chachi.

He is known as “Chicago’s Original Voice of the National Anthem,” having performed The Star-Spangled Banner an estimated 5,000+ times. He hosts The Wayne Messmer Radio Show, Sunday Nights, (7–8 pm) on 90.9FM/WDCB.org. His album with legendary pianist Judy Roberts, So Lucky To Be Loving You, has received rave reviews. He regularly appears on stage as a vocalist with his jazz group or Big Band.

Messmer has performed the National Anthem for the Chicago Cubs since 1985. He also sang before Games 3 and 5 of the 2016 World Series. Wayne spent 13 seasons as soloist with the Chicago Blackhawks at the historic Chicago Stadium and can now be heard at Chicago Wolves Hockey games, the (AHL) team of which he is a founding partner and Senior EVP. He is the co-founder and co-owner of Wayne Messmer & Associates, LLC, a nationally recognized financial services firm.

The powerful story of Wayne’s miraculous comeback after being shot in the throat in a random act of violence, an armed robbery attempt on April 9, 1994 in Chicago has touched thousands of people across the



country. His experience is chronicled in his autobiographical book, *The Voice of Victory*.

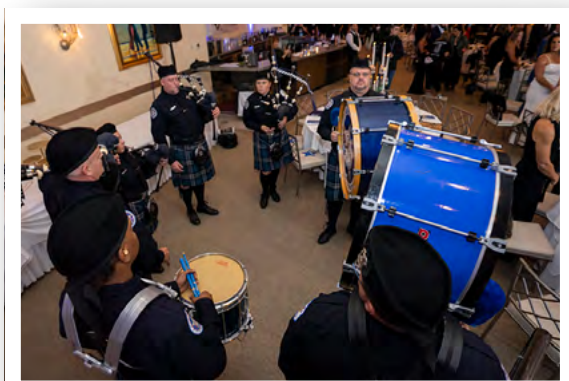

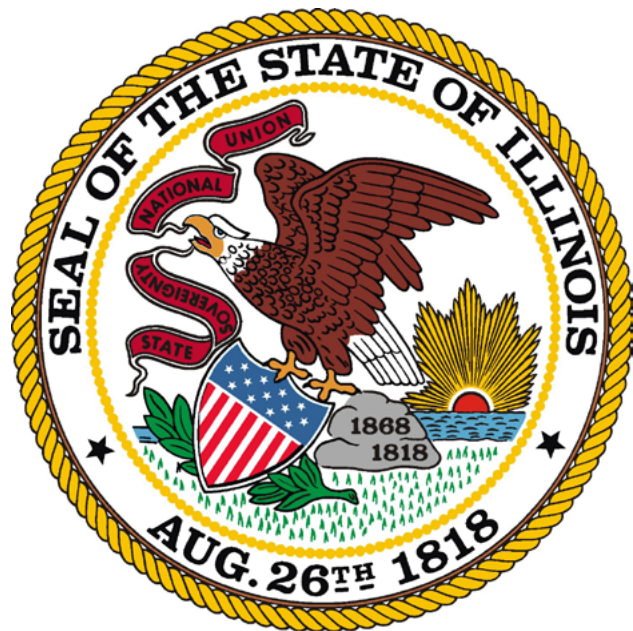

Father Tom is an experienced teacher, administrator, retreat director and parish mission preacher.

He is a native of the South Side of Chicago. He grew up in St. Adrian Parish in Marquette Park. He received his elementary school education at St. Adrian School and high school education at St. Rita of Cascia High School. He graduated from Villanova University with a B.A. in Communication Arts. He also has a Master of Arts in Educational Administration from Lewis University.

Fr. Tom entered the Midwest Province of the Augustinian Order in 1987. After completing his novitiate, he attended Catholic Theological Union in Chicago and graduated with a Master of Divinity degree.

In 1993 he made his solemn vows as an Augustinian Friar and in 1994 he was ordained to the priesthood.

He did a pastoral internship at St. Clare of Montefalco Parish in Grosse Pointe Park, MI, and taught theology at Providence Catholic High School in New Lenox.

Fr. Tom ministered for 21 years at St. Rita of Cascia High School in Chicago as a teacher, campus minister, Principal, President and Chairman of the Board of Directors.

Fr. Tom ministered for nine years as the Vocation Director for the Our Mother of Good Counsel (Midwest) and five years for St. Thomas of Villanova (Eastern) Province.

Fr. Tom spent two years as the Augustinian Advisor to the Office of First- and Second-Year Initiatives—Office of Student Life at Villanova University.

Fr. Tom ministered in Rome as part of the Pontifical Council for the Promotion of the New Evangelization where he was named a Papal Missionary of Mercy by Pope Francis in 2018. Father Tom spent two years as the Director of the Augustinian Marylake Shrine in King City, Ontario, and the Prior of the Marylake Augustinian Monastery.

Fr. Tom is currently in his 13th year as Vocation Director for the Midwest Province. Father Tom is the Director of St. Rita of Cascia Shrine Chapel in Chicago, IL, and the Director of Community Relations at St. Rita High School in Chicago. Father Tom is also the Prior of the Pre-Novitiate Community of St. Clare of Montefalco Friary in Chicago.

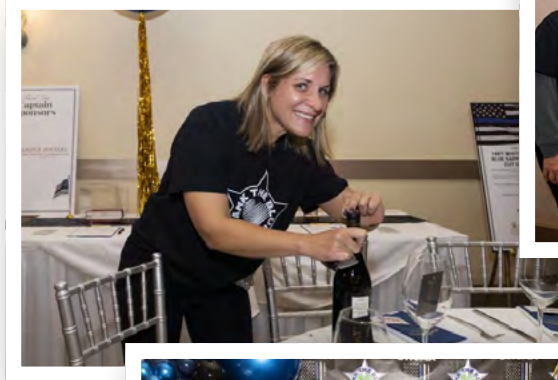
Father Tom continues to preach parish missions and lead retreats.

The feedback received from this program was nothing short of spectacular. We're grateful to the Cook County Sheriff's Police Lodge 4 for donating their lodge hall to host our bi-monthly Fatal 10 training sessions.



The Fatal 10 will help predict and manage suicide risk factors, suicidal ideations, and attempts among first responder groups. The idea is to identify and address red flags and questionable behavior before negative outcomes occur. This training will save lives, families, and careers. Dr. Olivia Johnson's training was developed from data collected from nearly 700 cases of law enforcement and correctional officer suicide. Ten major themes were noted as contributors to these deaths and became known as the FATAL 10.

Upon completion, learners will be able to:

- ✓ Demonstrate verbally the components of the Fatal 10
- ✓ Identify personal and occupational risk factors (on and off-duty)
- ✓ Identify common profile of a police officer suicide based on the Fatal 10
- ✓ Develop a game plan to reduce risks through inoculation

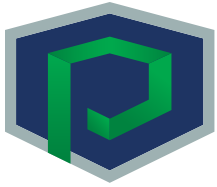

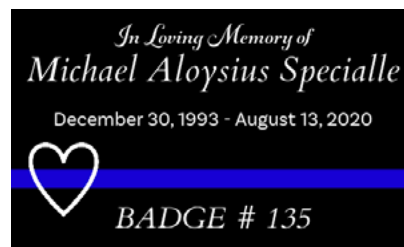

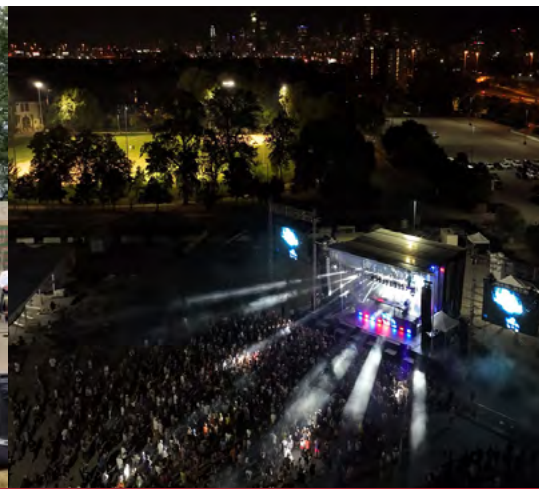
